**Document Public Comments:**

Staff Comments: Some 6-12 teachers believe that we need to limit students utilizing distance learning to prearranged, long term situations and not allow students to attend for individual days of alleged illness. A lower elementary teacher has expressed a desire to allow the 2 class groups within the same grade level to play together at recess.

Parent Comments: Some parents have expressed that their children had difficulty with remote learning and as Covid cases decline, they are now more comfortable sending their students to school for in person instruction. Parents want more than 2 people per athlete to be able to attend basketball games if possible.

**Reconfirm how instruction (Return to Learn Plan) is going to be delivered during the 20/21 school year:**

We will continue to follow the adopted 2020-21 Extended Learning Plan and offer K-12 Face To Face instruction with an option for remote instruction as needed. We will allow the 2 classes at the same grade level to be in the same area for recess with the expectation of limiting close contact with students not in their classroom cohort. We will allow basketball spectators to the maximum amount permissible when considering MHSAA and/or MDHHS guidelines for our gym's seating capacity. Parents, students and staff will be informed that distance learning is only an option for students who are quarantined or have otherwise prearranged it as a long term plan - it will no longer be an option for intermittent illness effective Feb 22, 2021. Teachers will not be required to allow students who are not pre-approved distant learners to attend a Google Meets during intermittent absences from school. Only pre-approved distant learners will be marked as 'present' when attending remotely.

**Reconfirm whether or not the district is offering higher levels of in-person instruction for English language learners, special education students, or other special populations:**

All K-12 student populations have the same options at this time (in person, distance or virtual). All Special Education students have had a Contingency Learning Plan (CLP) completed that specifies how their needs will be met if they are attending remotely.
