### Review Weekly 2-Way Interaction (Attendance) Rates for Elementary (K-5)

**Document Public Comments:**

Staff Comments: Staff has been involved in the conversations regarding spring events and whether they are held virtual, outside or inside with limited spectators. At this point, the spring band concert is planned to be virtual and the Honors Convocation will be in the gym with outside doors open and limited attendance.

Parent Comments: Some parents have expressed a concern about the health aspects of having students required to wear masks while exercising in PE. PE classes will be outside until the end of the year weather permitting. Students will not be required to wear masks while outside.

Some parents expressed frustration by recent quarantines. We will use the newly approved contact tracing guidelines from the Health Dept to only send low risk letters for students within 3-6 feet of a Covid case in school.

**Reconfirm how instruction (Return to Learn Plan) is going to be delivered during the 20/21 school year:**

We will continue to follow the adopted 2020-21 Extended Learning Plan and offer K-12 Face To Face instruction with an option for remote instruction as needed. We will continue to monitor local cases, positivity rate and numbers of students/employees who are positive or probable to determine if we need to make future changes to upcoming spring events.

**Reconfirm whether or not the district is offering higher levels of in-person instruction for English language learners, special education students, or other special populations:**

All K-12 student populations have the same options at this time (in person, distance or virtual). All Special Education students have had a Contingency Learning Plan (CLP) completed that specifies how their needs will be met if they are attending remotely.
